RESOLUTION NO. 2021-03

Adopting Ward Plan and Combining Municipal Wards for Voting Purposes

WHEREAS, Wisconsin Statutes, Section 5.15, requires all cities, villages, and towns with a population of 1,000 or more to establish municipal wards based on the results of the 2020 Census; and

WHEREAS, Wisconsin Statutes require that each municipality designate the various wards to be created within the municipality by consecutive whole number, geographical description, and population.

NOW, THEREFORE BE IT RESOLVED, that the Town of Spring Brook adopts the wards described as follows:

Ward 1 – That part of the *Town of Spring Brook*, more fully described as follows; Beginning at the intersection of County Road "J" and the west line of the Town of Spring Brook; Thence southeasterly, along said centerline of County Road "J" until it intersects with the centerline of County Road "C"; Thence easterly, along the centerline of said County Road "C" until it intersects with the centerline of County Road "H"; Thence southerly, along the centerline of said County Road "H" until it intersects with the thread of the Chippewa River; Thence, mostly westerly, along said thread of the Chippewa River, until it intersects with the said west line of the Town of Spring Brook; Thence north, along said west line of the Town of Spring Brook, to the point of beginning of this description.

Ward 1 Population: 329

Ward 2 – That part of the *Town of Spring Brook*, more fully described as follows; Beginning at the intersection of County Road "J" and the west line of the Town of Spring Brook; Thence southeasterly, along said centerline of County Road "J", until it intersects with the centerline of County Road "C"; Thence easterly, along the centerline of said County Road "C", until it intersects with the centerline of County Road "H"; Thence northerly, along the centerline of said County Road "H", until it intersects with the north line of said Town of Spring Brook; Thence west, along said north line of the Town of Spring Brook, to the northwest corner of said Town of Spring Brook; Thence south, along said west line of the Town of Spring Brook, to the point of beginning of this description.

Ward 2 Population: 493

Ward 3 – That part of the *Town of Spring Brook*, more fully described as follows; Beginning at the northeast corner of said Town of Spring Brook; Thence south, along the east line of said Town of Spring Brook, until it intersects with the thread of the Chippewa River; Thence, westerly and southerly, along said thread of the Chippewa River until it intersects with the centerline of County Road "H"; Thence, northerly, along said centerline of County Road "H", until it intersects with the north line of said Town of Spring Brook; Thence, east, along said north line of the Town of Spring Brook, to the northeast corner of said Town of Spring Brook, to the point of beginning of this description.

Ward 3 Population: 865

BE IT FURTHER RESOLVED that Wards 1, 2, and 3 created herein are hereby combined for voting purposes so as to share the common polling place, and such combined wards shall use common ballot boxes and ballots and maintain common election returns for the combined wards at any election for which all officers or referendum questions to be voted on are the same.

BE IT FURTHER RESOLVED that separate returns shall continue to be maintained for the combined wards at any election except where separate ballots are required under Section 5.62 and 5.64 of the Wisconsin Statutes.

Upon passage, a copy of this Resolution shall be filed with the Town Clerk, who shall transmit a copy of the ward plan and this Resolution to the County Clerk within five days of its adoption. This Resolution shall remain in effect for each election until modified or rescinded, in accordance with Statute, or until a new division is made following the next Federal decennial census.
