**TOWN OF SPRING BROOK
CLASS B ROAD ORDINANCE NO. 2024-01
"320th Avenue, also known as Fall City Road"**

The Town Board of the Town of Spring Brook, Dunn County, Wisconsin has the specific authority under Sec. 349.15(2), Wisconsin Statutes, to adopt this ordinance.

This ordinance, adopted by a majority of the Town Board on a roll call vote with a quorum present and voting and proper notice having been given, designates town highways as Class "B" highways in the town as follows:

- A. The following town highway in the Town of Spring Brook is designated a Class "B" highway subject to the weight limits set forth in Sec. 348.16(2), Wisconsin Statutes, unless increased by Town ordinance.

**320th Avenue (also known as Fall City Road)
From County Road C (S25, T27N, 12W) to 790th Street (S30, T27N, 11W)**


- B. The Town Chairperson, or his or her designee, shall place appropriate traffic signs on the above-described highway on or before the effective date of this ordinance.
- C. No person may operate any vehicle on the above-noted highway in violation of the weight limits set forth in Sec. 348.16(2), Wisconsin Statutes. Upon conviction for a violation of this ordinance, the violator shall pay a forfeiture of not less than \$100.00 nor more than \$100.00, plus the applicable surcharges, assessments, and costs for each violation. Each trip in violation of this ordinance constitutes a separate offense. In addition, the Town Board may seek injunctive relief from a court of record to enjoin further violations.

This ordinance is effective on April 1, 2024, following publication or posting of this ordinance and following erection of signage.

The Town Clerk shall properly post or publish this ordinance as required under Sec. 60.80, Wisconsin Statutes.
