Board members agreed that adjoining landowners to the parcel should be made aware of the purchase availability of the property. It was agreed to take offers for the purchase of this parcel with offers to be considered at the February 10, 2025, Regular Town Board Meeting.

Road Patrolman Mitch Kreutzer reported on the shop large garage doors' panels needing replacement. One estimate has been obtained with the intent to obtain another estimate for comparison. Boom mowing is underway with some tree trimming planned for the near future. Ice conditions from water run-off on 408th Avenue are being monitored.
