Citizen's Forum - Town Resident Dennis Stahlbusch inquired of the proposed Muddy Creek Solar project. The Public Service Commission (PSC) of Wisconsin recently issued a

letter of receiving an "application from Muddy Creek Solar, LLC, for the construction of a new 322 megawatts (MW) solar electric-generating facility, a 300MW Battery Energy Storage System (BESS), electric substation, and a 344-foot-long generation tie line (project)." Being that the project is over 300 megawatts, per Wisconsin Statute 66.0401, regulation of a solar

project this size is strictly by the PSC of Wisconsin. There was also a general inquiry of a few hundred acres in the Town of Red Cedar that has been annexed to the City of Menomonie with future building plans on that acreage of possibly a "Data Center." Mr. Stahlbusch exited the Treasurer Colleen Mensing presented the Financial Report. Both the Checking and Money Market (Savings) Accounts are at Dairy State Bank. Jerry Hotchkiss provided a brief update on the Menomonie Rural Fire/EMS District Agreement with the City of Menomonie. Legal representation of the District was anticipated to meet with City of Menomonie officials.

Irrigation spray on Town roads was discussed. A draft letter to irrigation landowners and users was reviewed to notify about enforcement over irrigation water on Town roads.

Board members were in consensus to consider an ordinance pertaining to irrigation waters landing on Town roads and to include a \$250 fee or penalty for noncompliance. Discussion was, upon notification of irrigated water on a Town road, the landowner or user would have two weeks to correct the irrigation spray and, if noncompliance, a \$250 fee or penalty would be charged to the landowner plus the cost(s) to repair the Town road. Unpaid Town charges may

be placed on the tax roll as a Special Charge to the Town's landowner.

Road B. It is thought to include 300+ acres and be used to construct a "Data Center." Many municipalities in Dunn County were asked to include this topic on their September meeting agendas. No action was taken on this agenda item. Board members discussed the Straw Hill Road/boat landing (240th Avenue off the Chippewa River). The boat landing is listed as owned by Robert A. and Ruth E. Brendsel Revocable Trust. The road leads from the boat landing and north towards the old Straw/Sand Hill Cemetery. The Town has maintained the boat landing and has ethically disposed of waste left at the site. There was conversation to consider closing the road each Winter season. No action was taken on this item but it was agreed to include it on the October meeting agenda.

Clerk Mary Strand provided a printed report and also shared the Building Inspector Report; the Menomonie Fire Department Report for July 2025; two Sanitary Reports; two

Register of Deeds Reports of parcel sales; a report regarding water testing at the Spring Brook Town Hall from Dunn County Land and Water Conservation; a Clean Sweep flyer; and a copy of a letter that the Public Service Commission (PSC) of Wisconsin has received an application from Muddy Creek Solar, LLC for construction of a new 322 MW solar electricity generating

Patrolman Mitch Kreutzer reported pot hole filling and grader patching are almost complete. He is repairing prairie/farm roads with added base and grading for planned heavy hauling this Fall. Mowing of ditches is underway. Paving of 710th Street was done today. Paving of 1008th Street is planned for tomorrow. Haas Sons, Inc., will shoulder 750th and 710th Streets. Crack filling and tree trimming were both completed last week. Improvements to 408th Avenue are complete with a 15" culvert added, 2" foam put over the culvert to aid in less freezing, and the ditches being seeded. Jerry Hotchkiss/Mike Hase moved to adjourn.
